Treasurer

GRANT MONIES

Given the complexities of 2020 it is fortunate that Friends of Innamincka do not have any Grant Monies outstanding this year.

CONSERVATION

The amazing Coongie Lakes has benefited from good water flows in 2020.





A bird survey at Coongie would be a wonderful experience in 2020 but for Covid 19. However, the track to Coongie is overgrown and impassable





in some areas with grass at 1.5 metres in height.

Coongie Lakes is a very special place in the **world**. Euan Moore (pictured below) works each year to monitor this KBA, (Key Bird Area) as designated by BirdLife Australia and BirdLife International. Coongie Lakes was added to the world RAMSAR list in 1990s. This is clearly stated on the signage in the AIMS building.



The Ramsar Convention on Wetlands. is of International importance. It holds the unique distinction of being the first modern treaty between nations aimed at conserving natural resources. The signing of the **Convention** on Wetlands took place in 1971.

The aim of the Australian Guidelines is to facilitate improved management of Ramsar sites in line with Australia's commitments Ramsar Convention under the responsibilities under the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act). The Guidelines provide а framework for Ramsar Convention implementation in Australia provide jurisdictions and other interested parties with clear guidance on the management of Ramsar sites.

Given that there has been a good deal of water flowing down the Cooper this year, as is seen by the photographs of the Causeway in January





and May

– it beggars belief that cattle are roaming through Coongie Lakes at the present moment!!

Friends of Innamincka saw the devastation wrought by cattle on this precious landscape in 2017



and spent days erecting and repairing fencing in order to prevent a repeat of this pastoral activity.





Surely nobody has purposely left gates open or cut through the fencing to allow cattle access to Coongie Lakes??????

Road works have been happening aplenty in the Innamincka Reserves over the last 12 months.

Whilst I am sure that the 4x4 drivers will all enjoy a much smoother ride, I wonder if any thought was given to the surrounding landscape, the future degradation of these areas through further erosion and in particular to the survival of the very rare "Small-headed Toadlet" *Uperoleia capitulata*.

The late Professor Mike Tyler was most anxious that this species be protected. He

specifically asked Friends of Innamincka to try to protect the habitat of the "Smallheaded Toadlet" recorded only once in South Australia at Patchawarra Creek.






Cordillo Road 2020

I have grave concerns for the survival of this species in this location given the extent of the earth movement.

Bore Track was the beginning of the Friends of Innamincka annual formal Bird Survey and reporting. The 5 year cycle was repeated along the Bore Track in 2019, however, it didn't look like this

Erosion does occur naturally but it has been exaserbated by the earth movement being undertaken to build "straight-line" roads for infrequent use by mining vehicles.

Yandruwandha Yawarrawarrka and **Peoples**



but for all Australians.

This fragile land gives plenty



but we must protect it!!

BIRD SURVEY

2020 Was to be the second year of our "Comparative" Reporting with our Bird Survey work. This year it was to be the Coongie Track 5 year comparison. Disappointingly we can not gather that data however, our "Roving Bird Reporter", Jason, has noted "Old Man Emu" along the track near Policeman's carefully guarding his 4 chicks, and 3 Bustards on the Coongie Track.
